And whereas, the Chief Engineer PWD (Roads) has engaged the party as "Graduate Engineer (Civil)" on a purely contractual basis for a period of 11 (eleven) months from the date of joining as mentioned in the Order issued by the Chief Engineer PWD (Roads) for contractual engagement of Graduate Engineers (Civil)subject to the fulfilment of the terms and conditions of the contractual agreement and party has agreed to serve the Department on contractual basis as per contractual agreement in that capacity on the terms and conditions herein after contained.

NOW THESE PRESENT WITNESS AND THE Parties hereto respectively agrees as follows:-

- 1. The party of the first part shall remain in the contractual service of the Department as Graduate Engineer (Civil) from the date of joining i.e.till the completion of contractual period (Contractual Period as mentioned in the Order issued by the Chief Engineer PWD (Roads) for contractual engagement of Graduate Engineers (Civil) which shall constitute an integral part of this Contract Agreement subject to fulfilment of terms and conditions mentioned in the contract agreement.
- 2. During the period of contract, while functioning as Graduate Engineer (Civil), the Party will be entitled to the compensation package/benefits as set out in the Appendix-I hereto which shall constitute an integral part of this Contract Agreement. The party shall not be entitled to any other compensation package/benefits except the compensation package/benefits as set out in Appendix-I during the contract period.
- 3. The Order issued by the Chief Engineer PWD (Roads) for contractual engagement of Graduate Engineers (Civil) is purely on a contractual basis for a period of 11 (eleven) months only and the Party would not be entitled to any claims, rights, interests, pensionary benefits, PF claims or any other benefits including regularisation or consideration of further appointment to the said post or any other post under the Department.
- 4. The service of the Party shall stand automatically terminated after the expiry of contract period, without any necessity of the Department giving any notice to the Party and without any liability on part of the Department to pay any retrenchment or other compensation or other amounts to the party.
- 5. Any action either directly or indirectly of the party for the change of posting will be according to the **Transfer policy of PWD (Roads) Department.**
- 6. The Party will have to stay within 2 km radius of the place of posting.
- 7. The performance appraisal will be conducted Quarterly for all the contractual employees under PWD (Roads) Department by HPIU.

- 8. The contract of the Party shall be terminated at any time by the Chief Engineer PWD (Roads) if the performance of the Party is found to be unsatisfactory or below the minimum expected levels or if the party is found to be guilty of any insubordination, dereliction of duty or any other misconduct. The agreement with the party shall also be terminated if the party is found to be unauthorizedly absent from the duties for continuous 7 (seven) or more days. In that case, the party shall have no right to claim for continuation in the contractual service.
- 9. Either of the parties hereto have the right to terminate this Agreement without assigning any reason before completion of contract period; provided that a written notice of one month is given to the other party. Both the parties may, in lieu of the written notice, given the other party a sum equivalent to the amount of his salary for one month or shorter notice than one month with a sum equivalent to the amount of his remuneration for the period of which such notice falls short of 1 month.
- 10. The Courts in Guwahati will have the exclusive jurisdiction in respect of all matters pertaining to contractual agreement between the Department and the Party, during contract period.
- 11. The party will be entrusted to supervise the on-going Civil works under concerned Division and as desired by his superior officers.
- 12. They will check the quality of the works and will insists on testing of items of work as per specification to ensure proper specification of work.
- 13. If required party may be entrusted for survey and preparation of estimates or any other works as assigned to.
- 14. Party appointed on contract basis can be assigned, in addition to the specific task for which appointed, to any other duties by the Department.
- 15. That after completion of contract period, the party is debarred and shall have no right for preferring any litigation before any competent jurisdiction for claiming their permanency or regularisation or continuing of their service in the department. Contractual job is valid for contract period only and once the contract period is over no party has any right whatsoever and they are debarred from claiming any right by way of any means before any competent jurisdiction.
- 17. Contractual Agreement does not give or confer any right over the party to claim regularisation or permanency of their service or continuing of their service in the department.
- 18. The department has the right to go for regular appointment through APSC during the existence of contractual agreement or after expiry of contractual agreement through regular process. In that case, the party shall not have any right for their continuation in the contractual service.
- 19. During the existence of the contractual agreement if under unavoidable circumstances the department is unable to release the salary of the party for two consecutive months or more in that case the party has no right to claim for any interest or pressurise the department for immediate release of the salary.
 - No notice of resignation will be effective if it is given during the leave period and the party will not be entitled to proceed on leave during the notice period.

- 21. During the contractual period, the party will wholly devote to the work assigned to him/her and will not undertake any other employment either on full or part time basis. Any contravention of this condition will entail termination of the service of the party.
- 22. As and when the department comes to know of any conviction by the Court of law during the tenure of contractual service or conviction and/or any or any bad record in the past under previous employer, or because of giving false information at the time of appointment or conceal any material information or given any false details in the application form or otherwise as regards as, educational qualification and other qualification, experience etc., the Chief Engineer PWD (Roads) immediately terminate the contractual service of the party and would take criminal action against the party as per law.
- 23. In witness thereof, the Party and the authorized signatory of the Department have hereunto set their hands the day and year first above written.

Agreement between Chief Engineer PWD (Roads) And Mr./Ms. _____ S/D/O___ Agreed Compensation Packages for the post of Graduate Engineers (Civil).

Remuneration:

The party shall be credited / paid a consolidated monthly total pay and remuneration @ Rs. 35,000.00 (Rupees thirty-five thousand) only (i.e. remuneration @ Rs. 30,000.00 + Rs. 5000.00 conveyance allowance) per month in their valid Savings Bank Accounts of any Nationalized Bank.

Leave:

During the term of contractual period, the Party will be entitled for a casual leave of 1 (one) day per month which can only be earned after completion of one month of term of contractual period. Casual Leave lapses at the end of the term of contractual period cannot be carried forward or used for encashment.

In case of illness, the Party is obliged to inform the Chief Engineer PWD (Roads) immediately by written communication. If the illness lasts for more than 3 days, a medical certificate must be produced. No more than six sick leave days will be recognized during the term of contractual period. The casual leave and sick leaves are over and above the State Government Holidays.

Holidays:

Holidays will be as per the State Government's Holiday List.

Travelling Allowance:

Where for the purposes of the Programme the Party may be required to travel outside HQ as per direction of the authority. No TA, DA will be entertained for any travel to be made outside of the HQ.

TDS:

The Department shall deduct income tax at source (TDS) as per Income Tax Act, which shall be deposited from the remuneration of the Party.
