- 2. In pursuance of Rule 260H(1) of the Rules of Procedure and Conduct of Business in Assam Legislative Assembly, Hon'ble Speaker has been pleased to constitute the Departmentally Related Standing Committee on Works Department on 18th July, 2016 for a period of one year. The Notifications are appended at Annexure-I & II.
- 3. The Committee scrutinized the various documents and relevant papers including the status paper received from the Public Works Department and also took the personal evidence of the Departmental representatives of the Department on the said Demands for Grants in its meeting held on 14th February, 2017.
- 4. The Committee considered the draft Report and adopted it on 18th February, 2017.
- 5. The Committee places on record its appreciation to the representatives of the Public Works Department for extending their cooperation to the Committee and the Officials of Assam Legislative Assembly Secretariat attached to the Departmentally Related Standing Committee on Works Department for their full co-operation and unstinted assistance.
- 6. The Committee also places on record its thanks to the representatives of Finance Department and also the Planning & Development Department for assisting the Committee in its deliberation.

CHAPTER-I

REPORT

- 1.1 The Public Works Department is one of the most important Department of the Government of Assam. The Department was initiated in the year, 1880 during the British reign. The Department has been divided into two Departments viz (1) Public Works (Roads) Department and (2) Public Works (Building & NH) Department.
- 1.2. The Department is carried out by different activities through the followings:-
 - (i) Chief Engineer (Roads)
 - (ii) Chief Engineer (NH)
 - (iii) Chief Engineer (Border Roads)
 - (iv) Chief Engineer (ARIASP & RIDF)
 - (v) Chief Engineer (Building)

Moreover, Mechanical and Electrical are the two Wings in the Department. The Mechanical Wings headed by an Additional Chief Engineer (Mechanical) and the Electrical Wings is headed by an Additional Chief Engineer (Electrical).

- 1.3 The Government is implementing authority of many schemes and projects for improvement of road network in the State. Out of total length of 3,717 k. m. of National highways (NH) in Assam, 2,134.8 k. m. is under the jurisdiction of Public Works (Building & NH) Department.
- 1.4 The Public Works Building & NH Department has to maintain Govt. Residential and Non-Residential Buildings of different Departments including State Secretariat Building etc. To enable sustainable building construction, energy efficient Green Building concept is being introduced in all ongoing and future major building projects.

1.5 The Government has given priority to construct Weather beaten roads and RCC Bridges. Special initiative has been taken up under CM's Special Packages for improvement of the road network. Special Package for improvement of the inter-state border roads have also been taken up.

1.6

- i) Building wing of PW (Bldg. & NH) Department is entrusted for construction & maintenance Building/Infrastructure of different Government Department & Agencies.
- ii) Budget for the departments are under the Grant No: 17, 33 & 64
- iii) In the last DRSC in the para 1,4 it was mentioned that PW (Bldg & NH) Department has to maintain Government Residential and Non-Residential Buildings of different departments including State Secretariat Building. In this regard, it may be informed that the Budget provision for maintenance Government Residential and Non-Residential Buildings is not adequate to properly maintain the Government Buildings.
- iv) Last year i.e, 2015-16 Budget allocation fund released/ utilized for maintenance of different Buildings are Annexed.
- v) During 2015-16, some fund released through FOC could not be utilized/ disbursed due to late release.
- vi) The Building constructed by PWD are to be included in Building Registrar of the division. For routine maintenance of such Building borne in PWD Building Registrar an amount of approximately Rs 190.00 crore is required annually. But due to inadequacy of required budget provisions the building could not be maintained as per requirement.
- vii) In respect of the new infrastructure/ Building Construction entrusted to this department adequate budget provision and timely release of fund would be much helpful in timely completion of the project. The present process of release of fund may be reviewed to ensure timely release of fund expeditiously.
- viii) Some of the important construction works implemented by this department in the last few years and some on going works are as given below:
 - a. Construction of proposed New ALA Building at Dispur.
 - b. National Law College at Amingaon
 - c. Dr Bhupen Hazarika Memorial at Jalukbari.
 - d. Swarga Deo Chaolung Su-Ka-Pha Samanway Kshetra at Mohbondha, Jorhat.
 - e. Assam House Shillong opened etc other Assam Houses are in progress
 - f. Judicial Courts in different places are in progress etc.

- ix) Conservation of nature and optimum use of natural resources is now becoming a global concern.
- x) This department is trying to make the construction activities more echo friendly, energy efficient. For example
 - a) This department has already made an MOU with TERI for updating of knowledge in the field of environment friendly infrastructure construction.
 - b) Road construction by adopting Soil Stabilization/ Soil improvement may help in a great way in preserving nature.
 - c) Introduction of LED, use of solar power, natural light & air etc. Some measures taken by the department to make the infrastructure more energy efficient.
- (xi) Above all the departmental officers are facing much inconvenience in supervision due to non-availability of vehicle. It may be mentioned that jurisdiction of few Building division covers two or more nos. of districts. Therefore in the interest of better supervision & timely completion of on going projects, sufficient number of vehicles up to the level of AEE is most essential.
- 1.7 The PW (Bldg.& NH) Department takes up Building works and works on National Highways of its own and also execute and supervise the construction works of other various Departments like GAD, Judicial Department, AR&T Department, H & FW Department, Education Department, ALA etc. including repair and maintenance works of the Buildings bears in the Departmental registers. This Department also look after construction and repair works of National Highways in Assam.

The payment for works executed by this Department of its own are made from budget provided in different Head of Account under grant No. 17, 33, 64 annually and payment to the building works of other Department are made from budget make available to the Department concerned. The budget provision made for this Department during 2015-16 and 2016-17 are shown below including requirement during 2016-17 and expenditure liability of previous year 2015-16.

It is observed in the above chart that, Fund provision made during 2015-16 could not been expended during the year due to non issue of FOC from Finance Department and liabilities, created against the maintenance Head as shown and contractors were suffering acute financial constraints during the year. Accordingly requirement during 2016-17 is high as shown to pay the liabilities but inadequate provision of budget is made during 2016-17(as shown above).

Further, there are the following old liabilities to be cleared, but no fund provided in the budget 2016-17.

- 1. H/A-2059-ADB-Plan = Rs.83.90(L)
- 2. H/A-4059-ABY-Plan = Rs.171.00(L)
- 3. H/A-4216-ABY-Plan = Rs. 60.00(L)
- 4. H/A-3054-R&B-M&R NH-Non plan-9% Agency charge-Rs.5.00(C) but only Rs.1.00(C) is provided in the budget 2016-17.

Regarding the above, the liabilities will be continued to next year due to non consideration of the budget. For clearing the liabilities of NH Department against requirement of 500(L), only 100(L) is provided is 2016-17 which is quite inadequate even not enough to clear Court cases. Due to this shortage of budget provision this Department is in a very crucial state for execution and maintenance of the works under this Department.

Above of all, the officers of this Department at field level have no vehicles for movement to site of works to executive and supervise the works which creates trouble in maintaining quality of the works. To provide vehicles to the officers of building wing for obtaining best quality works requires 300.00(L) [20x7.00L+40x4.00L] but no budget provision is made in

in this regard.

As above, DRSC is requested for taking suitable steps in regards for enhance of the fund.

RECOMMENDATIONS TAKEN BY THE COMMITTEE MEETING HELD ON 14TH FEBRUARY, 2017

RECOMMENDATIONS TAKEN ON PWD DEPARTMENT:

- 1. Though the work volume of P.W. Building & NH Department has increased many fold, the Technical Manpower required for proper execution of the works has not been increased. For effective supervision of the works the technical manpower of the Department need to be increased proportionately. Moreover, all the vacant posts in the Department may be filled at the earliest possible time for smooth implementation of the time bound project.
- 2. At present the jurisdictions of the Divisions of the Public Works Building and NH Department are very large. Only 17 Nos. of Building Divisions and 10 Nos. of NH Divisions cover all the infrastructure Development Projects in the State. Even in 33 Districts of the State, only 14 Districts have Building Divisions which have to maintain the Govt. Buildings of the District. Similarly, there are nearly 4000 Kms of National Highways in the State. Inadequate no. of Divisions often creates lots of difficulties in timely attending the requirements. It is recommended that the Department may be strengthened with adequate no of building and NH Divisions.
- 3. Most of the Building Projects are taken up in the remote and far flung areas of the Districts. It is not feasible to have sub divisional level officers in all the Project location, though frequent inspection of work by the divisional and the sub divisional officers is a must for proper and timely implementation of the Projects in order to improve the mobility of the officers though it was recommended earlier that all divisional and sub divisional level officers of the Department is provided with proper vehicles, the proposal could not be materialised. Therefore, it is recommended that all divisional and sub divisional level officers of the Building wing are provided with proper vehicles. This will also facilitate the officers to meet the urgent requirements.

- 4. The Committee has observed that there is a budget allocation of Rs. 600 Cr for 2016-17, Rs. 800 Cr for 2017-18 and a commitment for keeping Rs. 600 Cr during 2018-19 for PWRD under the Maintenance Head of Account, the total being Rs. 2000 Cr for 3 (three) consecutive years. Moreover, there is direction from the Govt to take up the road maintenance works for the entire amount of Rs. 2000 Cr in advance. The Committee recommended for completion of the approval and tendering process for the entire work as early as possible.
- The Committee has observed that in tendering for the works under PWRD, some contractors quote very low rates at which they cannot be expected to be able to complete the work with the required quality standards. In some of such cases, the contractors are found to abandon the work at an incomplete stage. Receiving tenders at too low rates indicates that the bidder is not aware of the required quality standards and the financial risk involved. Therefore the Committee suggested PWD for finding a mechanism to reject the tenders at unworkable rates or seriously unbalanced tenders.
- 6. The Committee observed that some of the contractors blacklisted by the department on genuine grounds, manage to get some work orders again in PWRD by bidding under the names of some newly formed company/firm. The Committee recommended for a strong mechanism in the department to reject such contractors.
- The Committee observed that due to the strict qualification criteria, many local new contractors fail to get work under PWRD; as there are many aspirant contractors waiting for an opportunity to start a career in the construction industry, the Committee, in the interest of growth of the local construction industry, recommended for relaxing the qualifying criteria suitably to permit such contractors to submit tenders in PWRD

- The committee observed that many roads constructed long back under PMGSY are in bad shape in absence of maintenance works. The Committee recommended for repairing of roads from Repairing and Maintenance fund to bring the roads in good condition..
- The Committee observed that the department does not get enough time to utilize fund for new works received through SD, because the financial year almost ends by the time the approval and tender process is completed. To avoid delay so occurred, the Govt should allocate fund to the department in the regular budget itself, so that the department can start the work at an early date.
- **70.** The Commissioner & Spl Secretary, PWRD mentioned about the substantial amount of works going to be funded by the Govt of India under PMGSY and the need of a dedicated chief Engineer to look after PMGSY works. The Committee recommended for creation of a post of Chief Engineer for this purpose to ensure successful implementation of the PMGSY works.
 - II. The Committee recommends that the Contractors who fail to complete the work in time or who left 2/3 works half done, must be blacklisted and also penalty must be charged against them. The department is responsible to look into this matter so that they can't make tender in future
 - The Committee also decided to make accountable all the Executive Engineers who fails to execute the work.
 - 13. The Committee recommended that the PWD must take initiative for timely completion of the work and the department is responsible to review its quality.
- The Committee strongly recommended that all the IBs of the state and the PWD Quarters must be repaired and the present condition of those IB should be improved gradually.
- The Committee recommended the department to complete all the half done works of the SPA at an early date.
- The Committee recommended that Kalgasia Tengagaon via Bardanha PWD road eroded by river Beki should be reconstructed immediately.

- The Committee also directed that the PWD also be provided with sufficient funds of SDRF so that the roads and bridges which are washed away or damaged by flood can be constructed or repaired.
- 18. The Committee recommended three Division of PWD(B) respectively in Mangaldoi, Barpeta and Udalguri district. Moreover, the Committee also recommended new division of PWD(B) in all districts where don't have any division.
- 19. The Committee recommended that all the works of the National Highway No. 15 should be completed soon with special initiative by the department.
- 20. The Committee also suggests for Construction of RCC bridge at Rowta station near railway line over Dhansiri River under Udalguri district.

The action taken report on the recommendations made in the report may be submitted to the Committee within 90 (ninety) days from the date of presentation to the House.

Para 2.4

- 1. The proposal for creation of an O/O Addl. Chief Engineer, PWD, Barak Valley with H.Q. at Silchar by upgrading the O/o SE, PWD, Karimganj BRC Circle has been approved by Finance Department and notification has been issued.
- 2. The proposal for creation of a dedicated Chief Engineer, PWD for looking after PMGSY works has been moved to AR & T Department for necessary clearance but the file was returned back with the remarks to wait till report of the 7th Assam Pay & Productivity Pay Commission.
