ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

Dated Dispur, the __ September, 2024.

Whereas, in compliance of the order dated-30.11.2022 of the Hon'ble Gauhati High Court passed in WP(C)No.2243/2021, Departmental Proceedings has been initiated against Sri Baldeb Sinha, Assistant Executive Engineer (C), PWRD (the then AE, Pathakkandi & ratabari TRD) with the charges of financial indiscipline; dereliction of Govt. duties and responsibilities; violation of Govt. instructions, but also violation of rule 3 of the Assam Civil Service (Conduct) Rules 1965;and , indiscipline and misconduct, in connection with the execution of "Construction of road from Anipur-Zamuang NEC Road to Dakshin Rampur including CD work and routine maintenance for 5 (five) years under PMGSY, Batch - I for the year 2018-19, PMGSY Package No. AS.13-278, vide show cause eCF No.257970/56, dated-27.02.2023;

And whereas, the delinquent officer Sri Baldeb Sinha submitted replies vide his letter dated-07.03.2023 and accepted that he had signed on the comparative statement; however, the disciplinary authority on not being satisfied with all of his contentions; Sri Sanjiv Shyam, Chief Engineer, PWRD was appointed as Inquiry Officer;

And whereas, the report submitted by Sri Sanjiv Shyam dated-30.06.2023 found to be not conclusive and comprehensive and hence, in exercise of powers conferred under rule 9 of the Assam Services (Discipline & Appeal) Rules, 1964, a *denovo* enquiry was ordered by appointing Sri Paban Terang, Chief Engineer, PWRD, EAP, Assam as Inquiry Officer to conduct the inquiry in to the charges framed against the D.Os;

And whereas, the Inquiry Officer Sri Paban Terang, Chief Engineer, PWRD, EAP, Assam submitted the enquiry report vide letter No.CE/EAP/Enquiry40/2023/18, dated-29.12.2023, and based on the enquiry report and the associated documents in the enquiry report, glaring anomalies as well as manipulation in the entire process of cancellation/termination of original contract agreement and allotment of balance work, found to have been done by the delinquents and the D.O Sri Baldeb Sinha having signed the false comparative statement for balance work, committed misconduct and indiscipline and hence, the charges levelled against him found to be proved;

Now, therefore, after careful examination of all the above aspects of the matter, the departmental proceeding drawn up against Sri Baldeb Sinha, Assistant Executive Engineer (C), PWRD vide show cause notice eCF NO.257970/56, dated-27.02.2023 is hereby closed by imposing the following penalties under the provision of the rule 7 of the Assam Services (Discipline & Appeal) Rules, 1964:

- (i) Debarred from promotion to next higher rank for next 2(two) years; and,
- (ii) Stoppage of 1(one) increment with cumulative effect.
