**ADDENDUM to Notification No. eCF 369775/3 dated 12.09.2023**

Dated Dispur, the ..... September, 2023

**eCF No. 369775/15:-** In continuation of the Department's Notification eCF No. 369775/3 dated 12.09.2023, the following guidelines are to be carried out in view of the re-organization of Divisions / Offices under PWRD:

1. The concerned Executive Engineers and Assistant Executive Engineers will issue Notifications for re-designating and start functioning their Divisions & Sub-Divisions as mentioned above from the date of issue of this Notification positively.
2. Section Assistant, Sub-Engineers, Work Charged Staff and Muster Roll Labourers etc., attached to different roads will remain along with their respective roads as they were entrusted and accordingly they will be entrusted to the respective divisions in which the road falls.
  - a. The Executive Engineers will take over / hand over / assume charge of the designated Division within 30 days from the date of issue of the Notification.
  - b. Jurisdiction of the Respective Divisions, Sub-Divisions will be co-terminus with district, Sub-Divisions or LACs as the case may be as per Election Commission of India's Notification No. 282/AS/2023(DEL)/VOL.V, dated 11.08.2023.

However, territorial jurisdictions already demarcated earlier will remain same for the divisions, Sub-Divisions within the disposal of 6th (Sixth) Schedule areas.
  - c. All the ongoing works shall be implemented by the Divisions prior to re-organization, till the process of handing over & taking over charges is complete. However, the divisions which have been shifted to other districts shall hand over the ongoing work to the respective divisions in the re-organized structure.
  - d. Entire process to be completed within 30(thirty) days from the issue of this Notification.
  - e. Liabilities and bills of existing works created during the period of process of handing over and taking over of charges shall be cleared to the extent possible by the Divisions prior to re-organization.

Once it is completed, the balance work will be implemented by the new territorial division in which it falls.
  - f. In case of non-gazetted employees of any division which has been reorganized, due to merger of other Division / Sub-Divisions, the inter se-seniority will be re-fixed by counting services from date of joining in the Department by the concerned new appointing authority.
3. The concerned Superintending Engineer will send proposal to Chief Engineer, PWD(Roads) for demarcation of the selected jurisdiction of the re-organization of offices within 30 days from the date of issue of this Notification on the basis of the jurisdiction of LACs recommended by the Election Commission of India's Notification No. 282/AS/2023(DEL)/VOL.V, dated 11.08.2023 regarding delimitation of LACs in Assam.
4. The Executive Engineers should update their D.D.O codes as per their new names and locations in accordance with Election Commission of India's Notification No. 282/AS/2023(DEL)/VOL.V, dated 11.08.2023 and this office's Government Notification No. eCF 369775/3 dated 12.09.2023.

This applies to those Executive Engineers whose names / locations have got changed.
5. The territorial boundary of Goalpara West and Dudhnoi Territorial Road Division will be co-terminus with the boundaries of Goalpara West and Dudhnoi LACs.
6. The territorial boundary of Goalpara East and Jaleswar Territorial Road Division will be co-terminus with the boundaries of Goalpara East and Jaleswar LACs.
7. Sadia Territorial Road Sub-Division will remain at its original location and it will be under the control of Tinsukia, Doom Dooma, Makum & Sadia Territorial Road Division.
8. Batadroba, Dhing & Raha Territorial Road Division is re-named as Dhing & Rupohihat Territorial Road Division with Head Quarter at Nagaon with Dhing Territorial Road Sub-Division, Rupohihat Territorial Road Sub-Division under it.
9. Nagaon, Barhampur & Rupohihat Territorial Road Division is re-named as Nagaon-Batadroba, Raha & Barhampur Territorial Road Division with Head Quarter at Nagaon with Nagaon-Batadroba Territorial Road Sub-Division -I, Nagaon-Batadroba Territorial Road Sub-Division -II, Barhampur Territorial Road Sub-Division and Raha Territorial Road Sub-Division under it.
