ORDER

Whereas Prosecution Sanction was accorded against Shri Anjan Haphila, Junior Engineer (C), PWRD, the then Junior Engineer, Diyungbra Development Block, Dima Hasao, Assam in CBI Case No.RC 5(A)2011-SHG for committing irregularities in implementation of NREGA schemes vide letter No.CON.36/2013/46 dated- 31.05.2013;

Whereas the Court of the Special Judge, CBI, Assam, Addl. Court No.3, Chandmari, Guwahati vide order dated 30.12.2020 in Special Case No.13/2013 arising out of CBI Case No.RC 5(A) 2011-SHG convicted Shri Anjan Haphila, Junior Engineer (C), PWRD, the then Junior Engineer, Diyungbra Development Block, Dima Hasao, Assam and sentenced to suffer simple imprisonment for 1 (one) year and to pay a fine of Rs.5000/- in default simple imprisonment for another 3 months for the offence committed under section 120B, 468, 471 and 409 of IPC and to suffer simple imprisonment for 1 (one) year and to pay a fine of Rs.20000/- in default simple imprisonment for another 3 months for the offence under section 13 (1) (c), r/w Section 13(2) of Prevention of Corruption Act, 1988;

Whereas after careful examination of the Order dated 30.12.2020 of the Court of Special Judge, CBI, Assam in Special Case No.13/2013 and materials on record, the Disciplinary Authority has decided to inflict the penalty of 'Dismissal from Service which shall ordinarily be a disqualification for future employment' upon Shri Anjan Haphila, Junior Engineer (C), PWRD;

And whereas the Assam Public Service Commission on being consulted in the matter, has vide their U.O. issue No.1667, dated- 28.10.2022 agreed to the proposed penalty of 'Dismissal from Service which shall ordinarily be a disqualification for future employment' upon Shri Anjan Haphila, Junior Engineer (C), PWRD;

Now, therefore, the Governor of Assam in exercise of powers conferred under Article 311(2)(a) of the Constitution of India and Rule 10(i) of the Assam Services (Discipline & Appeal) Rules, 1964 is pleased to impose the penalty of 'Dismissal from Service which shall ordinarily be a disqualification for future employment' upon Shri Anjan Haphila, Junior Engineer (C), PWRD under Rule 7(vii) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.


