**No.286923/156:** Whereas, Sri Diganta Kalita, Assistant Executive Engineer(T/C), PWRD, East Guwahati Territorial Roads Division was placed under suspension vide Notification eCF No.286923/3 Dated 18.03.2023 for committing procedural and financial irregularities in utilization of funds while executing the works under MPLAD fund of Sri Ajit Kumar Bhuyan, Hon'ble Member of Parliament, Rajya Sabha for the year 2021-2022 and 2022-23;

And, whereas, Departmental Proceeding has been initiated against Sri Diganta Kalita vide Show Cause Notice No. E-286923/133 Dated 24.06.2023;

And, whereas, the Delinquent Officer has submitted his replies against the Show Cause Notice Dated 24.06.2023 vide his letter dated 20.07.2023;

And, whereas, consequent upon his denial of the charges, a departmental enquiry was constituted under Rule 9(4) & 9(5) of the Assam Services (Discipline & Appeal) Rule, 1964 by appointing an Inquiry Officer and a Presenting Officer vide Notification No. E-286923/2023/147 & 147-A Dated 05.08.2023;

And, whereas, the Inquiry Officer has submitted his report vide letter No. TEC/CM Vigilance/01/2023/4 Dated 14.09.2023;

And, whereas, the report submitted by the Inquiry Officer was found to be inconclusive and incomprehensive, the PWRD has decided to refer to State Enquiry Officer, Assam to conduct an inquiry on the said matter with the approval of Competent Authority;

Considering the facts and circumstances as stated above, the period of suspension in respect of Sri Diganta Kalita is hereby extended w.e.f. 18.09.2023 until further orders.
