Whereas, **Sri Indrajit Bora**, Superintending Engineer(C), PWRD, RAM Cell, O/o the Chief Engineer (Roads), Assam & Chief Engineer, Guwahati Municipal Corporation (on attachment) was arrested in ACB P.S Case No.17/2023, under section 7 (a) of the Prevention of Corruption Act, 1988 (as amended) on 22/03/2023 at about 5.00 PM as he had demanded bribe from the complainant of the aforesaid case of the Directorate of Vigilance & Anti – Corruption, Assam. There is prima – facie evidence against him.

And whereas; disciplinary proceedings have been contemplated against Sri Indrajit Bora, for the aforesaid act;

Now, therefore, in exercise of powers conferred under Rule 6(2)2.2.1 of the Assam Services (Discipline & Appeal) Rules, 1964, **Sri Indrajit Bora**, Superintending Engineer(C), PWRD, RAM Cell, O/o the Chief Engineer (Roads), Assam & Chief Engineer, Guwahati Municipal Corporation (on attachment) is deemed to have been suspended w.e.f the date of his arrest on 22/03/2023 pending drawal of Departmental Proceedings against him.

It is not permissible for him without previous sanction of the Govt. to accept private employment or to do business while under suspension in view of the provision of Rule 12 of the Assam Civil Services (Conduct) Rule, 1965. If while under suspension he accepts private employment, does business in violation of Rule 12 of the Assam Civil Services (Conduct) Rule, 1965, he will be guilty of misconduct and will be liable to dealt with accordingly. He is also liable in that case to forfeit his claim for subsistence allowance. The Head Quarter of Sri Indrajit Bora will be Guwahati. He will not leave the Head Quarter without prior written permission of the competent authority.
