- State Government shall accord technical and financial sanction of the above project within a period of four months from the date of administrative approval of the works failing which the works shall be deemed to have been disapproved unless revised administrative approval of the Government of India is obtained.
- The period of the completion of the projects is not to exceed 24 months including period for tendering. In any case this time schedule is to be strictly complied with.
