ORDERS BY THE GOVERNOR OF ASSAM

NOTIFICATION

Considering the increasing the number of Road Accidents in the State of Assam and in the interest of public safety, the Governor of Assam is pleased to fix the **Maximum Speed Limit** for all classes of motor vehicles on the State Highways, Major District Roads, Roads within the Guwahati Metropolitan Area, Roads within the Municipal Area in the State of Assam, as specified below:

Class of Roads	Maximum Speed Limit for all class of Motor Vehicles
State Highways / Major District Roads	50 km/hour
Within Guwahati Metropolitan Area	40 km/hour
Other roads within the Urban/Municipality areas	40 km/hour

However, the maximum speed limit near the Institutional areas for all classes of roads shall be 30 km/hour.

The above Speed-Limit for all classes of motor vehicles in the State of Assam shall be applicable with immediate effect and appropriate regulatory authorities of the Government (e.g. Transport Department, Police etc.) shall take penal action against the defaulters as per provisions in the Law.
