
The appointment is purely temporary and may be terminated at any time without assigning any reason thereof. The services are liable to be transferred at any district level offices all over in the State of Assam.

Further it is to mention that Government servant joining the services of the State Government of Assam on or after the 1st February ,2005 shall not be governed by the existing Assam Service (Pension) Rules ,1969 and orders issued there from time to time. So far as his pension and other retirement benefits are concerned, the services of the new appointee will be governed by the New Defined Contribution Pension Scheme as per Govt's new pension rules vide Finance (Budget) Department's OM No. BW.7/2008/Pt/40 , dtd. 06.10.2009. An undertaking from the candidate regarding acceptance of the New Pension Scheme is required to be obtained at the time of joining.


